A guide to rural enterprising in the West Midlands

what can the Rural Enterprise Grant (REG) do for you?

The Rural Enterprise Grant (REG) can fund small scale diversification and business development projects for the benefit of rural businesses. The Rural Enterprise Grant is funded under the Rural Development Programme for England (RDPE) and is available to farmers and specific rural micro-businesses in the West Midlands region. The regional RDPE programme is managed by Advantage West Midlands, the Regional Development Agency for the West Midlands Region; The Rural Enterprise Grant (REG) is being administered by Herefordshire Council.

Who can apply?

Funding is targeted at:-

- farm businesses

Or

- members of farming households

Or

- Micro-Enterprises: new or existing businesses of less than 10 employees whose turnover is equivalent to less than €2m

[located in eligible rural areas/whose core and planned activities are based on food and drink, Environmental Technologies or Tourism]

What will the REG grant fund?

Funds are available for eligible applicants for investments in Environmental Technologies, Food and Drink and Tourism related activities.

Eligible Activities:-

Food and Drink Diversification and Enterprise Development:

- Small scale processing and manufacturing activities (e.g. Meat cutting plant, small dairy processing unit)
- Supply chain equipment (processing, storage, specialised equipment/facilities)
- Retailing of locally produced food and drink via a farmshop (farmers only)

Support for Environmental Technologies:

- Bioenergy installations and recycling/waste equipment
- Renewable energy installations

Tourism Improvements:

- Rural tourist attractions, recreation and facilities which add value to the "visitor experience" (e.g. car-parking, signage, toilet and washing facilities)
- Farming enterprises can diversify into a range of leisure / tourism activities such as Equine concerns
- Improvements to existing Tourism enterprises to improve quality and provide facilities to extend appeal of business

Livestock Programme

- A Livestock grant relating to animal Health and Welfare and a Nutrient Management programme will be available to farmers at a future date

How much can I apply for?

- 40% of eligible grant up to a maximum of £62,500. The remainder of the funding must be from the private sector

What can't I apply for?

The following activities will not be eligible for REG funding:

- Creation of new tourism accommodation
- Retail apart from 'on farm' farm shops
- Speculative developments
- Purchase of livestock
- Investment in normal agricultural operations
- Vehicles

How do I apply?

If you think you are eligible:

- First contact the REG Scheme Manager at Herefordshire Council to discuss your proposal and confirm that you, where you live and your project, may be eligible for funding
- If it looks as if you are eligible the Scheme Manager will ask you to complete a Stage 1 Enquiry Form, which can be downloaded in Word or PDF format. You may also need to complete a State Aid declaration to let us know if you have received public funding over the last 3 years
- If the details of your project meet the initial criteria and priorities of the scheme, the Scheme Manager will invite you to complete a full application
- If you have not already done so, the Scheme Manager will also put you in touch with Business Link West Midlands who will help you assess any need for training or business advice. Funding is conditional on this
