**Malvern Hills District Local Development Framework:  
Draft Statement of Community Involvement (SCI)**

Please find enclosed a copy of the Draft SCI recently produced by Malvern Hills District Council.

The SCI sets out how the District Council will involve residents, organisations and businesses in the preparation of future planning documents and plans together with planning applications. The SCI is a statutory planning document and the Council is required to publish it for widespread consultation before submitting the document to the Secretary of State for consideration and adopting it as a Local Development Document. The main period of public consultation took place between the 6 May and 17 June and included formal adverts about the consultation placed in the local press.

You may have already been consulted by your own district council or unitary authority on the preparation of the SCI that affects your area, however, it has now been nationally established that this Council's main consultation exercise should have included neighbouring Parish Councils.
