

PART 3 – RESPONSIBILITY FOR FUNCTIONS

Introduction

The following details are set out in this part of the Constitution:

- Diagram of the Council's political management arrangements
- Detailed terms of reference and procedural protocols for each Committee/Panel
- Scheme of Delegation to Officers

The Council may alter the terms of reference or composition of any Committee from time to time or appoint any additional Committees as appropriate.

Subject to the provisions of the Constitution and any legal requirements, any function of a Committee may be delegated to any Committee or officer (but not to a single Councillor). A list of matters that are delegated to officers is contained in Part 3 of this Constitution.
