Although I am not resident within this Neighbourhood Plan area but in an adjacent one, I am a regular visitor to Hallow and its environs.

I full support Policies HAL 2-15. It is important to provide a good housing mix to support all age groups at the different stages of their housing needs and different income brackets.

Hallow is a beautiful village and it is important it retains its rural character and preserve its heritage with the appropriate policies on design and landscape (HAL 3 and 4) It is also important that it retains and enhances its infrastructure to support residents (HAL 10)

As a village it has had a substantial amount of new development in recent times, and it is important with any future development that areas of green space, important vistas and recreational facilities are not compromised and hence I fully support the policies protecting and enhancing these (HAL 11, 7 and 6)

Traffic volumes are an increasing issue in rural villages such as Hallow and Ombersley, and policies to support transport links and encourage walking and cycling are most welcome (HAL 15)

Overall, I feel this plan is a credit to the team who worked on it and an excellent planning document alongside the SWDP for the community of Hallow.


