There is a vocal minority within the village who, through a Facebook page, are opposing development. This group is opposed to all development in the village and, as far as I can tell, does not comment on a preferred site.

Although I understand why, I am disappointed that the current consultation process does not highlight that housing allocation will happen anyway and that the plan is a way of giving the village a say. This final part of the consultation process, in a pandemic, reduces the ability of the village to make this clear to residents. The plan and the consultation text on the Malvern Hills website is complex and not user friendly.

The request to use a separate form for each representation seems onerous.

The letter I received highlights a site allocation without making it clear that housing will be allocated to the village, regardless of the plan. I think that people will just read that as a headline and not bother so much about the rest.
