Since the submission of the Regulation 15 documents for Great Witley and Hillhampton Neighbourhood Plan, and the subsequent Regulation 16 consultation of July 2025, the Levelling Up and Regeneration Act 2023 received Royal Ascent on 25 March 2026. Specifically, under the Act, Section 98 and 99 have implications in terms of the content of neighbourhood plans and changes to the Basic Conditions Statement (BCS). Subsequently, Great Witley and Hillhampton Parish Council approved an addendum to the Basic Conditions Statement at the AGM meeting of 13 May 2026.
